# PARISH CHAIRMAN'S REPORT

I firstly acknowledge the dedicated Chairmanship of my predecessor Lyndon, and extend a vote of thanks to him for his faithful service. It is noted that the Vice Chairman's role was vacant for many years, and in latter times the volunteers to step into either role were in short supply. I imagine this would not have been easy on you Lyndon and we gratefully thank you, for holding the fort as you did. Praise be to God, that we have once again been able to appoint a Vice Chairman. The appointment of Sam Hentschke was ratified at the 2022 Half Yearly. Thank you Sam, for your willingness to serve in this role. I also acknowledge and show appreciation for Jodie Koch and the late Kevin Pfeiffer, for their service as the Parish Treasurers over a good many years. Thank you Jodie, for keeping our financial records in good order, and for liaising with our auditor on an annual basis. We applaud a job well done and with Jodie stepping down at this AGM, put the call out for anyone who may be interested in standing as Parish Treasurer. It really isn't that big of a job anymore, where there are just a handful of transactions each year. Please prayerfully consider if this is a role you would be willing to serve in? In my first 12 months as Chairman, I have been seeking to understand the current context in which the Parish, as an Incorporated Association operates. I have looked to the Constitution as one source of this understanding, while recognising that there has been much discussion of late, that the 2006 Constitution is not particularly fit for purpose at present. However, as I mentioned at the 2022 Half Yearly, until it's changed, together with the By Laws, it remains the official statement of the rules of how we are to conduct Parish business. Recently, I became aware that I did not have the latest copy of the By Laws, where a new version was adopted locally and signed by the District in 2010. A key change in these, gave greater autonomy and authority over some decisions to the Concordia/Outlying grouping of congregations. I apologise then, that some of what I requested be brought to the Half Yearly for ratification by the Members, did not actually need to be so. Thank you for people's trust, in at first following my lead, and subsequently the patience and gentleness showed in correcting my misunderstanding.

In terms of business conducted since the last AGM;

- I sought advice from the District about ensuring we continue to uphold our legal obligations and realised that some changes proposed to simplify business operations, can't take effect just yet, unless we revise the Constitution
- The LLL bank account was transferred into the name of Concordia/Outlying, as agreed by the Members
- A donation was made to the Lutheran School, toward Bibles presented to students
- We commenced the process of establishing a Parish bank account at BankSA in Loxton, in order to close the account with the Commonwealth Bank.

And, based on this meagre list, I was prompted to reflect on the purpose and definition of an Incorporated Association as a legal entity....as in 'why Incorporate'? Interestingly, this made complete sense while property was held and managed by the Parish, staff were employed, income and expenditure was significant AND new Ministries such as the School were being established and financially supported. However, with little of this context remaining now, there seems little reason to justify the Incorporation of the particular grouping of congregations in our Parish as a 'body corporate'. That's not to say that other groupings shouldn't form and where Incorporation does still make sense, which is therefore one avenue that could be explored. I have, this past year, had many conversations with people about the future of the Parish, understanding some of its history, but more importantly, turning to the possible solutions or aspirations Members hold for our congregations and ministries going forward. Several things are common and clear;

- we desire streamlined, or at least clearer governance
- the context of the Parish is entirely changed from that which it was in the past, and namely since 2006, the date of the current Constitution •
- we care about our Christian witness to the broader community of Loxton

- people are weary of just talking about it, and want to see action in some direction before too long
- we agree that meeting together as Lutherans, to support each other in mission and ministry is still important, and
- time for Members and congregations to explore and discuss options, will be important before decisions are implemented.

Collectively, we seem to agree that the Parish as an association, doesn't presently have a clear sense of common purpose. We could speak for days, about what that historically was, and the wonderful mission and witness over many years, in all of the things the Loxton Lutheran Parish has achieved and established. There is a clear and enduring legacy of God's Kingdom work in our community and surrounding areas. This is worth us celebrating! But it is very clear that the 'old' has become 'new', and this work is now happening in a more expanded, but also disaggregated way.....it is still happening, it has just outgrown the bounds of the previous frame of a single 'body corporate' - which is not necessarily a bad thing, it just means we should adjust. The verse that comes to mind for me, is Ecclesiastes 3:1 "There is a time for everything, and a season for every activity under the heavens". Where previously it was the Parish's time - to be born, to build, to plant, to gather the stones and to keep....I feel that there are at least some now, who feel that we should be having open discussion about what it might look like - to uproot, to tear, to throw away and to scatter....not in the negative sense of things necessarily.....just as a form of renewal, toward the generation of something better. So, this need not be out of weeping, or mourning, or hate, or war.....but IF it's time, perhaps we just peacefully agree it is time to make a change and then work through what that means for us, and what it looks like next? Towards that goal, Parish Council continued discussions about forming a group to determine the future of the Loxton Lutheran Parish. However, we agreed there are some strategic challenges for Lutheran churches across the whole LCA, greater and also similar, to those we face in Loxton. We therefore agreed instead, to join discussions at the Zone scale at the recommendation of the District, and see what comes of that for the moment, before considering what we might do in Loxton.

As Members of the Parish, we've discussed at times, the question about the witness we show our community, if the Parish as we know it was to dissolve, or if a Congregation chose to leave by Peaceful Dismissal for example. However, in recent times I've reflected on a few alternative views;

- if our frame and messaging about what the Parish stands for, is clouded by the articulation of our areas of disagreement, long-running issues, and past and new hurts, are we in fact doing more damage than good to our collective witness?
- could it be OK, or perhaps even good, if congregations had the freedom to choose, what to come together on, with whom....and where this may be on some things and not others?
- how much more effective a witness could we be, if we worked together by our choosing, not because we legally had to?, and
- by setting our foot to a different path, might we release some of our fervent mission-minded people, from the weariness they currently feel in trying to navigate this complexity? We might see opportunities for new or renewed mission and ministries, flowing out of people feeling freed and able to respond to the call of God on their lives. It is true for some of our Members and Parish Councillors, that their joy, hope and energy for mission are waning, while the mud feels deep in this quaggy mire of confusion and indecision, and there isn't a clear way out.

No solution will be perfect, nor perhaps acceptable to all, but if we commit to looking at the range of options (and many might exist), we can explore the possibilities and discuss what might be the implications of those, seeking God's wisdom and will in choosing which path to put our foot to.

I look forward to the discussions we will have, that bring hope through the possibilities. I also trust in the Lord that he will bless us with the attendance of additional Parish members at our AGMs and Half Yearlys, so that we might not have to struggle to meet quorum and can conduct our meetings as 'duly convened'. Please encourage your fellow Members to come along for the hour or so and stay also, for the cuppa and conversation afterwards.

In the ministry centre, we have replaced the phone system. The previous system just stopped working and couldn't be fixed. I continued to have monthly meetings with my pastoral supervisor. This is a compulsory requirement for all LCA pastors. In my continuing education program, I am focussing on developing skills in the area of teaching. My goal is to develop and fine-tune skills for engaging and effective communication and teaching of God's word in the Church. I am up to date with all my safe church requirements and trained to the coordinator level. I am a synod delegate and attended the recent LCA Convention of Synod in Melbourne.

# Assistant Pastor's Report 2023

The past year has again been dominated by Covid 19. The pandemic has now moved toward an endemic phase and many precautionary behaviours in our church community have been relaxed according to State and LCA guidelines. Thankfully, the holy things of God, His Word and Sacraments, have been available to sustain our faith throughout. Besides our Sunday worship program, pastoral acts across C&OL (and elsewhere) have included 9 funerals and 6 baptisms, and one wedding. With Meribah moving into recess and Myrla, New Residence and Moorook congregations working harmoniously together as if a single group, the C&OL group is functioning effectively as a three-point 'parish'.

Pastor Darrin Kohrt, faithful shepherd of C&OL for 16 years, died at the end of July. His funeral in August was probably our most moving occasion of the year; our thoughts and prayers remain with Vanessa and his loved ones in the USA, and some plans for memorial plaques are underway in appreciation. We were also blessed to celebrate the 126<sup>th</sup> anniversary of Concordia in May at which Pastor Kohrt was particularly and surprisingly buoyant. We have also experienced a 'changing of the guard' in our office with Lynn Schmaal assisting initially as Bronny Cook was withdrawing, and finally employing Ethan Grosse for the job. In the meantime a Call committee has begun meeting and making preparations to call a pastor to fill the vacancy.

I continue to function between my call to Riverview as part time chaplain and 'stop -gap' duties of ministry for C&OL. And I continue to be grateful for Pastor Chris Georg who helps fill the breach of a regular pastor.

I managed to avoid Covid over the last couple of years until October when I attended General Pastor's Conference; about 40 other pastors of the roughly 200 that attended came down with Covid from that event.

As I write this I am preparing to attend General Synod in Melbourne; it is a cause of high stress and anxiety for the sake of the future of the LCA, and has put me personally into a 'holding pattern' about my own remaining ministry before retirement, and the implications of this Synod's decisions. Four times before over the last 22 years, the church has prayed for the Spirit's guidance and decided according to its formal procedures to uphold the teaching of Scripture declared at union of the ELCA and UELCA that God has given the 'Preaching Office' to men only. But these decisions have been ignored. The milieu of our present day and age is relentless and we are asked to decide the matter yet again at this Synod. The LCA is therefore at a crossroads where laity, pastors, and congregations on either side of the matter will have the invidious choice of faithfulness to Scripture (as each understands that) versus institutional unity of the LCA.

Finally, I thank all those who have prayed for the church, nurtured their faith by availing themselves of the means of grace, and have let these means flow from them in acts of love and service to each other and our community no matter how menial your work may have seemed.

On a personal level, Anna and I thank you for your kindness, care and acceptance shown to us. We welcome you to drop by for a casual visit sometime; the coffee machine and kettle are always ready!

# LUTHERAN CAMP KEDRON

## REPORT

The operation of the Camp continued to be affected during the 2021/2022 year from restrictions associated with Covid 19. The most noticeable reduction in campers was from the Education sector with schools cancelling or deferring bookings until late 2022/23. The recent publicity associated with high water levels, closure of Lake Bonney and blue-green algae outbreaks has also affected camp bookings this summer.

### Annual General Meeting & Constitution

The Annual General Meeting was held on Sunday 17 October 2022 at the camp. In conjunction with the AGM, a vision and planning discussion occurred where many good ideas were forwarded to improve our campsite and make it sustainable into the future. It was encouraging to see some new faces in attendance.

We are appealing for a couple more persons to join the management team who have an interest in the long term future of Kedron. Meetings are a combination of physical meetings at Barmera or conducted online. Additionally a few working bees are usually scheduled each year. A huge shoutout is extended to Daryl Cook for his dedication and care for the camp.

### Camps

During the 2021/2022 financial year, Kedron had 42 bookings for 139 days involving 1172 adults & 36 children (aged 5-8 years). This was a 38.08% utilization. (This is a reduction from 2020/2021 with 42 camps for 153 days @ 45.5%, reflecting groups are shortening the length of their camps).

During the first 6 months of 2022/2023, Kedron has held 18 camps involving 605 adults & 34 children with a utilisation rate of 36.95% for the 184 days the Camp was open. This is a reduction compared to 42.4% for 24 camp in the first half of 2021/2022.

### Camp Improvements

The planning for the ablutions blocks upgrade has progressed slowly with little to show on the ground. We anticipate more changes in the next 12 months.

### Supporters and Donations

In June 2022, we lost one of our most dedicated supporters with the passing of Gladys Noll. Our condolences are extended to husband Albert and his family. Gladys will be missed by many. Our future working bees will not be the same.

# RIVERVIEW LUTHERAN RESTHOME LOXTON CHAIRPERSON'S REPORT 2022-2023

## CHAIRMANS ANNUAL REPORT 2021-2022

Our mission at Riverview Lutheran Rest Home is to provide quality care to the lives of our residents.

Our Christian values are embedded in everything we do and are reflected in the everyday life at Riverview. Care, Respect, Kindness, Compassion, Quality, Love, Patience, and Integrity.

The challenges of working under the COVID-19 pandemic requirements and best practice guidelines compounding this by the shortage of staff in the aged care industry, I continue to be very thankful for the wonderful carers, nurses, and administration team, who have worked incredibly well together to deliver the highest possible care.

Under this umbrella Riverview recorded a very favourable current year surplus of \$281,887.

On the 28<sup>th</sup> of August 2021, a certificate of Occupancy was formally received for the Chapel Wellbeing Centre, the final cost of the build was \$1,831,603.95. The dedication of the Chapel Wellbeing Centre by Bishop Altus and Pastor Avito DaCosta was held on the 17<sup>th</sup> of November 2021, unfortunately this was not open to the public due to COVID-19 restrictions. This facility is being enjoyed by our staff and residents.

The board pays a special tribute to Pastor Kohrt who resigned due to ill health in January 2022. He served Riverview Rest home for 13 years as a board member and was a tireless advocate and supporter of the Chapel Wellbeing Centre. Pastor never saw the completion of this project due to ill health. Pastor Kohrt passed away July 22<sup>nd</sup> 2022.

The improvement and upgrading of Riverview facilities continues.

The Traeger courtyard decking has been completed, this area is now a useable space for residents, the upgrade has had very positive feedback from staff and residents.

Work is near completion in the upgrading of the Edwards hallways.

The change over of the doors / windows, the painting of the hallway and rooms, the installation of carpet squares and finally, the laying of stonework will complete renovations.

The upgrade of the hallways and rooms will have significant benefit for residents, staff, and visitors, giving a much quieter and homely feel.

The old air conditioners in the resident's rooms have been replaced with split system air conditioners, resulting in less noise and better air temperature control.
